SECTION 1. That the City Manager is hereby authorized and directed to execute the attached agreement with ARCADIS U.S., Inc. for additional owner representative consulting services related to the ongoing improvements at the City of Oberlin Raw Water Pump Station and Water Treatment Plant in an amount not to exceed \$4,154.89.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit:

"to authorize additional payment for owner representative consulting services as soon as possible relating to the ongoing improvements at the City of Oberlin Raw Water Pump Station and Water Treatment Plant" and shall take effect immediately upon passage.

WTP IMPROVEMENTS RPR WORK AUTHORIZATION NO. 1

This Work Authorization is entered into by and between ARCADIS, a Delaware corporation ("ARCADIS") and City of Oberlin ("Client"). This Work Authorization incorporates by reference the Professional Service Agreement entered into by the Parties dated April 2008 (the "Services Agreement"). The Services Agreement is herby amended and supplemented as follows:

GENERAL DESCRIPTION OF BASIC SERVICES
