## ORDINANCE No. 12-21 AC CMS

AN ORDINANCE AMENDING ORDINANCE 11-49 AC CMS TO AUTHORIZE AN INCREASE IN THE CONTRACT AMOUNT WITH QUALITY CONTROL INSPECTION, INC. (QCI) OF BEDFORD, OHIO, TO PROVIDE FOR ADDITIONAL PROFESSIONAL CONSTRUCTION INSPECTION SERVICES FOR THE NORTH PROFESSOR, WOODLAND AND UNION STREETS PAVEMENT IMPROVEMENT PROJECT IN THE CITY OF OBERLIN AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the contract with Quality Control Inspections, Inc. (QCI), of Bedford, Ohio, for professional construction inspection services for the City of Oberlin, Ohio, as previously approved by Ordinance No. 11-49 AC CMS, as amended, is hereby amended to authorize an additional payment of \$5492.40 for additional services, in accordance with Section 2 set forth hereinafter.

SECTION 2. That the project for which said services shall be utilized, and the maximum fee to be charged is as follows:

North Professor, Woodland and Union Streets	
Pavement Improvement Project	\$54,523.20

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit:

"to authorize additional inspection and testing services as soon as possible in order to ensure timely payment for service rendered", and shall take effect immediately upon passage.
