AN ORDINANCE AMENDING ORDINANCE 97-28 AC CMS AS AMENDED WHICH ESTABLISHED FEES AND CHARGES FOR VARIOUS SERVICES, PERMITS AND LICENSES OF THE CITY OF OBERLIN, OHIO TO CORRECT THE FEE FOR FINGERPRINT CARDS FOR THE OBERLIN POLICE DEPARTMENT AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That Ordinance 97-28 AC CMS as amended which established fees and charges for various services, permits and licenses of the City of Oberlin, Ohio is hereby amended to reflect the changes and additions shown on **Exhibit A** attached hereto and incorporated herein by reference.

SECTION 2. It is herby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the City of Oberlin, Ohio or to provide for the usual daily operation of a municipal department, to wit: to implement a fee for electronically submitted fingerprints for the purpose of a civilian background check as soon as possible to allow the police department to offer this service to the community, and shall take effect immediately upon passage.
