

**ORDINANCE NO. 07-04 AC CMS**

**AN ORDINANCE RESCINDING ORDINANCE NO. 99-12, ESTABLISHING FEES FOR CIVIL SERVICE COMMISSION EXAMS FOR FULL-TIME ENTRY LEVEL POSITIONS AND DECLARING AN EMERGENCY**

**BE IT ORDAINED**, by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

**SECTION 1.** That Ordinance No. 99-12 AC CMS, which established fees for Civil Service Commission exams for full-time entry level positions, is hereby rescinded.


**SECTION 2.** It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit:

"to avoid charging a fee for full-time entry level Civil Service examinations at the earliest possible date", and shall take effect immediately upon passage.

## ORDINANCE NO. 99-12 AC CMS

AN ORDINANCE AMENDING ORDINANCE NO. 97-28 AC CMS WHICH ESTABLISHED FEES AND CHARGES FOR VARIOUS SERVICES, PERMITS AND LICENSES OF THE CITY OF OBERLIN, OHIO

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That Section 1 of Ordinance No. 97-28 AC CMS, which established fees and charges for various services, permits and licenses of the City of Oberlin, Ohio, is hereby amended to establish the following as the reasonable fee for the services indicated:

SECTION 2.
