AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH UTILITY TRUCK EQUIPMENT, INC. OF CIRCLEVILLE, OHIO, THROUGH THE STATE OFFICE OF PURCHASING FOR THE PURCHASE OF AN AERIAL LIFT TRUCK FOR OBERLIN MUNICIPAL LIGHT AND POWER SYSTEM AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That pursuant to Ohio Revised Code Section 125.04 and City of Oberlin Resolution No. R88-7, the City Manager is hereby authorized and directed to enter into a contract with Utility Truck Equipment, Inc. of Circleville, Ohio, through the Department of Administrative Services Cooperative Purchasing Program for the purchase of a Versalift VST 6000 Aerial Lift Truck for Oberlin Municipal Light and Power System for a purchase price of \$171,190.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, and safety of the citizens of the City of Oberlin, or to provide for the usual daily operation of a municipal department, to wit:

"to authorize the purchase of equipment necessary for Oberlin Municipal Light and Power System as soon as possible to ensure the efficient operation of the City of Oberlin," and shall take effect immediately upon passage.

Our 2007 capital budget includes the purchase of a new aerial lift truck for the Electric Distribution Division. We are respectfully requesting procurement of this aerial lift truck through the Ohio Department of Administrative Service's Cooperative Purchasing Program. Utility Truck Equipment, Inc. (UTE) of Circleville, Ohio is the authorized vendor for this equipment through a State Term Schedule (STS) 778515AB. I have attached a copy of the applicable State Term Schedule and the preliminary order summary from UTE for the Versalift VST-6000 aerial lift truck.

The Versalift VST 6000 will be utilized for daily operation and maintenance of the City's electric distribution system. This truck will have a working height of 62', include a 2 man bucket and have a articulating/telescoping boom. This truck will provide the necessary working height as well as maneuverability for utility personnel to construct and maintain our distribution system, in particular, on taller poles which increasingly are becoming commonplace in our distribution system. To offset the cost of the new truck, we propose to surplus and sell a used 65' double bucket truck purchased in 1988. This truck has not been usable as a daily operator due to it chassis size as well as its non-articulating, elbow boom set-up. Retail value of this truck is estimated at \$16,000 to \$18,000.


As you will see on page 1 of UTE's order summary, the base contract price plus standard options is \$159,395. Distribution staff are recommending some additional non-standard options shown on page 2 and 3 of the order summary at a cost of \$11,795 bringing the total cost to \$171,190. Our approved 2007 capital budget request for this purchase was \$166,000. This price was based on being able to procure a 2007 International Chassis. A 2007 International chassis is not available due to new EPA guidelines on engine emissions. Capital funds are available to complete the purchase of this truck at \$171,190.

Attached is a draft ordinance for this purchase on first reading only. I respectfully request that this ordinance be placed on the May 7th City Council agenda. Utility Truck Equipment has completed Equal Employment Opportunity documents which have been forwarded to the Code Administration office. I will provide a verbal report on UTE complying with EEO requirements. Terry Evans, Distribution Superintendent, will be on hand to answer any questions related to this purchase. In the meantime, if you have any questions, just let me know.

SPECIAL OBERLIN BODY COMPARTMENTATION

CURBSIDE COMPARTMENTATION

<u>First Vertical 25.75"</u> - Fiberglass transverse compartment with aluminum treadplate overlay, installed between the #1 compartments. Includes a full width flat shelf with no lip, 10" down from top, extending fully into each #1 compartment. Shelf to be open for access from both sides.

Full height vertical partition installed on body centerline below top transverse shelf. Partition extends from bottom of shelf to transverse floor, to divide each half into a 29" wide section.

Three (3) full width pull-out material drawers on curbside under transverse shelf. Drawers extend fully into the curbside #1 compartment. Bottom drawer is 6" deep, top two (2) drawers are 4" deep. Each drawer to be equipped with removable criss-cross dividers and a spring loaded retaining latch.

<u>Second Vertical 25.25"</u> - Access opening to body cargo area. Two (2) gripstrut steps in access opening, evenly spaced, with bottom step flush with bottom of body sidebox. An opening shall be provided between the back of each step and riser panel to allow mud and ice to fall through. Includes two (2) 45 degree angled grab handles, one (1) each side of access opening.

6" removable composite retainer board installed across access opening at cargo floor level.

Third Vertical 21.25" - Three (3) adjustable shelves with adjustable dividers.

<u>Fourth Horizontal 53.50" -</u> Two (2) full length shelves with twelve (12) adjustable dividers each, one (1) in center and one (1) on bottom of compartment.

<u>Fifth Vertical 39.68" –</u> Seven (7) locking swivel material hooks mounted as high as possible, 2-3-2.

STREETSIDE COMPARTMENTATION

Hotstick shelf located in the top of streetside sidebox, 10" down from top, running from the front of the second vertical compartment to the rear of the body, with a drop down access door on rear body panel.

<u>First Vertical 25.75"</u> - Access to upper transverse compartment shelf (note – this shelf extends fully into this compartment).

Third Vertical 27.25" - Three (3) adjustable shelves with adjustable dividers.

<u>Fourth Horizontal 53.50" –</u> Full length bottom shelf with twelve (12) adjustable dividers.

<u>Fifth Vertical 39.68" -</u> Seven (7) locking swivel material hooks mounted as high as possible, 2-3-2.
