ORDINANCE NO. 07 - 56 AC CMS

AN ORDINANCE ACCEPTING THE BID OF PRO-SAFE FIRE TRAINING SYSTEMS, INC.,
OF NOBEL, ONTARIO, FOR THE PURCHASE OF A LIVE FIRE TRAINING SYSTEM FOR THE
OBERLIN FIRE DEPARTMENT
AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the bid of Pro-Safe Fire Training Systems, Inc., of Nobel, Ontario, for the purchase of a Live Fire Training System for the Oberlin Fire Department, being the lowest and best bid submitted, is hereby accepted, and the City Manager is hereby authorized and directed to enter into a contract for same in the amount of \$400,145.00.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, and safety of the citizens of the City of Oberlin, OH or to provide for usual daily operation of a municipal department, to wit:

"to authorize the purchase and upgrade of firefighter protective equipment as soon as possible to ensure the efficient operation of the Oberlin Fire Department," and shall take effect immediately upon passage.
