RESOLUTION NO. R10-01CMS

A RESOLUTION REQUESTING THAT THE COUNTY AUDITOR, PURSUANT TO OHIO REVISED CODE SECTION 5705.03, CERTIFY TO THE CITY OF OBERLIN THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THE RENEWAL, REPLACEMENT OR REPLACEMENT AND INCREASE OF A FIRE PENSION LEVY, AND DECLARING AN EMERGENCY

- WHEREAS, a levy for fire pensions, pursuant to Ohio Revised Code Sections 5705.19 (w) and 5705.25, were approved by Oberlin voters on May 3, 2005, and expired December 31, 2009, with the last collection year being calendar year 2010; and
- WHEREAS, in order to continue to pay for fire pensions, renewal, replacement, or replacement and increase of the 5-year levy, beginning with tax duplicate year 2010, first collected in 2011, needs to be placed on the May 4, 2010, ballot.
- NOW THEREFORE, BE IT RESOLVED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:
- SECTION 1. Pursuant to Ohio Revised Code Section 5705.03, the City of Oberlin hereby requests that the Lorain County Auditor certify to the City of Oberlin the total current tax valuation of the City and the dollar amount of revenue that would be generated by a renewal of the 0.6 mill levy for Fire Pensions, the amount of revenue that would be generated if the same levy was replaced instead of renewed, and the amount of revenue that would be generated from a replacement of 0.60 mill with an increase of 0.10 mill totaling 0.70 mill instead of renewed, as authorized by Sections 5705.19 (w), 5705.192 and 5705.25 of the Ohio Revised Code.
- **SECTION 2.** The Clerk of Council is hereby directed to certify a copy of this Resolution to the Auditor of Lorain County.
- **SECTION 3**. It is found and determined that all formal actions of this Council concerning or relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- **SECTION 4.** That this Resolution be and hereby is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit:

"to ensure that the Lorain County Auditor certifies the total current tax valuation of the City and the dollar amount of revenue that would be

generated in order to pass legislation for the renewal, replacement or replacement and increase of the levy detailed in Section 1 hereinbefore prior to the deadline for placing tax levies on the May, 2010 ballot,"

and shall take effect immediately upon passage.
