RESOLUTION No. R13- 08 CMS

A RESOLUTION SUBMITTING THE QUESTION OF A RENEWAL TAX LEVY FOR THE PURPOSE OF CURRENT EXPENSES OF THE OBERLIN PUBLIC LIBRARY TO THE ELECTORS OF THE TERRITORY SERVED BY THE LIBRARY, PURSUANT TO SECTIONS 5705.19 (D) AND 5705.23 OF THE REVISED CODE AND DECLARING AN EMERGENCY

WHEREAS, the Board of Library Trustees of the Oberlin Public Library has determined that a renewal tax levy of 1.5 mills is necessary for the proper operation of the Library; and

WHEREAS, on February 12, 2013 and March 12, 2013, the Board of Library Trustees of the Oberlin Public Library duly adopted Resolutions carrying out statutory procedures and declaring that the amount of taxes which may be raised within the ten-mill limitation by levies on the tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of the Oberlin Public Library, a municipal public library serving the City of Oberlin and the territory of the Oberlin City School District not in the City and the residents thereof; and

WHEREAS, those Resolutions request this Council, as the taxing authority for the Oberlin Public Library and pursuant to Sections 5705.19 (D) and 5705.23 of the Revised Code, submit the question of a renewal tax levy of 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars of valuation, to the electors of the territory served by the Library at an election to be held therein on November 5, 2013; and

WHEREAS, this Council is in receipt of a certificate of the Lorain County Auditor, dated March 6, 2013, provided at the request of the Oberlin Public Library in connection with these tax levy proceedings, which states that the total current tax valuation of the territory served by the Oberlin Public Library is \$179,897,730 and that the amount of revenue that would be generated by the proposed 1.5-mill renewal levy would be \$269,748 annually during the life the levy, assuming that the total current tax valuation of the territory served by the Library remains the same throughout the life of the levy.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

Section 1. In accordance with the aforesaid Resolutions of the Board of Library Trustees of the Oberlin Public Library, a municipal public library, it is hereby found, determined and declared that the amount of taxes which may be raised within the ten-mill limitation by levies on the tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of the Oberlin Public Library and it is therefore necessary to levy a renewal tax in excess of such limitation for the purpose of the current expenses of the Oberlin Public Library in the total amount of 1.5 mills for five years.

Section 2. The question of a renewal tax levy of 1.5 mills for the purpose of the current expenses of the Oberlin Public Library for five years, beginning with the tax list and duplicate for the year 2014, the proceeds of which levy first would be available to the Board of Library Trustees in calendar year 2015, shall be submitted under the provisions of Sections 5705.19 (D) and 5705.23

of the Revised Code to the electors residing within the boundaries of the territory served by the Oberlin Public Library, as defined by the State Library Board and set forth in the preambles hereto, at an election to be held therein on November 5, 2013, as authorized by law, and that the election shall be held within the territory served by the Library at the regular places of voting established by the Board of Elections of Lorain County, or otherwise, within the times provided by law and shall be conducted, canvassed and certified in the manner provided by law.

Section 3. The form of the ballot to be cast at the election on the question of this tax levy shall be substantially as follows:

**OBERLIN PUBLIC LIBRARY
PROPOSED RENEWAL TAX LEVY**

A majority affirmative vote is necessary for passage.

A Renewal tax of 1.5 mills for the benefit of the Oberlin Public Library for the purpose of the current expenses of the Oberlin Public Library at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars in valuation, for five years.

Section 4. The Clerk of this Council be and is hereby authorized and directed to give or cause to be given notice of said election as provided by law.

Section 5. In accordance with Resolution # R-13-3-5 of the Board of Library Trustees of the Oberlin Public Library, approved on March 12, 2013, said Board of Library Trustees determined and declared that it would pay or reimburse the City of Oberlin for the costs, as certified by the Board of Elections, of placing the 1.5 mill renewal tax levy on the November 5, 2013 ballot. In accordance with said Resolution and the policies of the Lorain County Budget Commission, this Council directs that such election costs be deducted from moneys of the Oberlin Public Library instead of the City's general fund.

Section 6. The Clerk of Council be and is hereby directed to certify a copy of this Resolution, the two Resolutions of the Board of Library Trustees and the certification of the Lorain County Auditor referred to in the preambles hereto to the Board of Elections of Lorain County, Ohio, not later than August 7, 2013.

Section 7. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Resolution were adopted in an open meeting of the Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.







**NOTICE OF ELECTION ON TAX LEVY
IN EXCESS OF THE TEN MILL LIMITATION**

Notice is hereby given that in pursuance of Resolution No. R13-08 CMS adopted by the Council of the City of Oberlin, Ohio on June 3, 2013, there will be submitted to the electors residing within the boundaries of the territory served by the Oberlin Public Library, as defined by the State Library Board (being all of the territory of the City of Oberlin and all of the territory of the Oberlin City School District not in the City), at an election to be held in that territory at the regular places of voting therein, on Tuesday, November 5, 2013, the question of levying a tax in excess of the ten-mill limitation for the benefit of the Oberlin Public Library for the purpose of current expenses of the Oberlin Public Library at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars of valuation, for five years. Said tax constitutes the renewal of all of an existing 1.5 mill levy. If a majority of the voters voting thereon vote in favor thereof, said levy will be placed on the tax list and duplicate in December 2014 for first collection in calendar year 2015.





The Board of Library Trustees of the Oberlin Public Library, a municipal public library of the City of Oberlin, met in Regular session on March 12, 2013, commencing at 5:00 p.m., in the Owen Room at the Oberlin Public Library, 65 South Main Street, Oberlin, Ohio, with the following members present:

Mary Kirtz, Meredith Gadsby, Mary Picken
Audrey Kolb, Julia Binder, Jeff Baumann

Kirtz moved the adoption of the following resolution:

A RESOLUTION DETERMINING TO PROCEED WITH A REQUEST TO THE CITY OF OBERLIN TO SUBMIT TO THE ELECTORS OF THE DISTRICT SERVED BY THE OBERLIN PUBLIC LIBRARY THE QUESTION OF A RENEWAL TAX LEVY FOR THE PURPOSE OF THE CURRENT EXPENSES OF THE OBERLIN PUBLIC LIBRARY, PURSUANT TO SECTION 5705.23 OF THE REVISED CODE.

WHEREAS, by a Resolution adopted on February 12, 2013, and in accordance with Division (B) of Section 5705.03 of the Revised Code, this Board requested that the Lorain County Auditor certify (i) the total current tax valuation of the territory served by the Oberlin Public Library and (ii) the dollar amount of revenue that would be generated by a 1.50 mill renewal levy; and

WHEREAS, the County Auditor certified that the total current tax valuation of the territory served by the Oberlin Public Library is \$179,897,730 and the amount of revenue that would be generated by that 1.50 mill renewal levy would be \$269,748 annually during the life of the levy, assuming that the total current tax valuation of the territory served by the Library remains the same throughout the life of the levy;

NOW, THEREFORE, BE IT RESOLVED by the Board of Library Trustees of the Oberlin Public Library, County of Lorain, State of Ohio, two-thirds of all of its members concurring, that:

Section 1. It is hereby determined and recited that the Oberlin Public Library is a free municipal public library created to serve the residents of its territory as defined by the State Library Board by an Ordinance passed by the Council of the City of Oberlin for such purpose; accordingly, this Board is charged with the title, custody, control and maintenance of a public library and is entitled to proceed under Section 5705.23 of the Revised Code to initiate and deliver proceedings to the City of Oberlin for the submission of the question of a renewal 1.50 mill levy for the purpose of the current expenses of the Oberlin Public Library to the electors residing within the boundaries of the territory served by the Oberlin Public Library, as defined by the State Library Board pursuant to Section 3375.01 of the Revised Code, being all of the territory of the City of Oberlin and the territory of the Oberlin City School District not in the City.

Section 2. This Board hereby finds, determines and declares that the amount of taxes which may be raised within the ten-mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of the Oberlin Public Library and that it is therefore necessary to levy a renewal 1.50 mill tax levy in excess of such limitation on all property within the boundaries of the territory

served by the Oberlin Public Library, as defined by the State Library Board pursuant to Section 3375.01 of the Revised Code, for the purpose of the current expenses of the Oberlin Public Library for 5 years.

Section 3. Pursuant to said Section 5705.23 of the Revised Code and having received and reviewed the aforesaid certification of the Lorain County Auditor, this Board hereby requests the City of Oberlin to submit to the electors residing within the boundaries of the territory served by the Oberlin Public Library, as defined by the State Library Board (being all of the territory of the City of Oberlin and all of the territory of the Oberlin City School District not in the City), at the election to be held on November 5, 2013, the question of a renewal 1.50 mill levy outside of the ten-mill limitation for 5 years, beginning with the tax list and duplicate for the year 2014, the proceeds of which levy would first be available to this Board of Library Trustees in calendar year 2015.

Section 4. This Board hereby finds, determines and declares that the levy of such tax, if approved by the electors, is necessary for the proper furnishing and rendering of free public library services by the Oberlin Public Library for the persons residing within the boundaries of the territory served by the Oberlin Public Library, as defined by the State Library Board.

Section 5. The Fiscal Officer of this Board is hereby authorized and directed to forward a certified copy of this resolution, the resolution adopted by the Board on February 12, 2013, and the certificate of the County Auditor referred to in the preambles hereto to the Clerk of Council of the City of Oberlin.

Section 6. This Library Board of Trustees hereby determines and declares that it will pay or reimburse the City for the costs, as certified by the Board of Elections, of placing a 1.50 mill renewal tax levy on the November 5, 2013 ballot, and, in accordance with the aforesaid policy of the Lorain County Budget Commission, the County will deduct those costs from moneys of the Library instead of the City's general fund.


