ORDINANCE NO. 17-51 AC-CMS

AN ORDINANCE AMENDING THE CITY OF OBERLIN ZONING MAP TO REZONE 288 AND 312 SOUTH MAIN STREET FROM "M-1"/LIGHT INDUSTRIAL DISTRICT USE CLASSIFICATION TO THE "R-1"/SINGLE-FAMILY RESIDENTIAL DISTRICT USE CLASSIFICATION

WHEREAS, the Planning Commission has reviewed the properties at 288 and 312 South Main Street located in the "M-1"/Light Industrial District use classification to determine whether the current zoning is the appropriate classification for these properties; and

WHEREAS, the Planning Commission has determined that the rezoning of 288 and 312 South Main Street from "M-1"/Light Industrial District to "R-1"/Single-Family Residential District would recognize existing residential development, eliminate non-conforming uses, facilitate the appropriate future use and improvement of these parcels and better enable future purchasers to obtain the financing necessary for the sale or improvement of these properties; and,

WHEREAS, the Planning Commission has voted to recommend to the City Council that 288 and 312 South Main Street be rezoned from "M-1"/Light Industrial District to "R-1"/Single-Family Residential District; and,

WHEREAS, this Council has held a public hearing concerning the Planning Commission's recommendations.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

SECTION 1. That the parcels of real property known as 288 and 312 South Main Street, identified in Exhibit "A" attached hereto are hereby rezoned from "M-1"/Light Industrial District to "R-1"/Single-Family Residential District.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this ordinance shall take effect at the earliest date allowed by law.
