ORDINANCE No. 18-10 AC CMS

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH LEBANON FORD INC. OF LEBANON, OHIO, THROUGH THE STATE OFFICE OF PURCHASING FOR THE PURCHASE OF A 2018 FORD F-550 DUMP TRUCK FOR THE OBERLIN MUNICIPAL LIGHT & POWER SYSTEM AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, not less than five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That pursuant to Ohio Revised Code Section 125.04 and City of Oberlin Resolution No. R88-7, the City Manager is hereby authorized and directed to enter into a contract with Lebanon Ford Inc. of Lebanon, Ohio, for the purchase of a 2018 Ford F-550 Dump Truck for the Oberlin Municipal Light & Power System for the purchase price of \$57,580.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit: to authorize the purchase of a 2018 Ford F-550 Dump Truck as soon as possible to ensure the efficient operation of the Oberlin Municipal Light & Power System," and shall take effect immediately upon passage.
