ORDINANCE No. 18-63 AC CMS

AN ORDINANCE AMENDING ORDINANCE 18-54 AC CMS AUTHORIZING THE CITY OF OBERLIN TO COOPERATE WITH THE OHIO DEPARTMENT OF TRANSPORTATION FOR ODOT PID 87698, PREVENTIVE MAINTENANCE OF US ROUTE 20 IN THE CITY OF OBERLIN, OHIO, AND DECLARING AN EMERGENCY

WHEREAS, on the 16th day of April, 2018, the City of Oberlin enacted Ordinance 18-24 AC CMS authorizing the City to cooperate with the Director of the Ohio Department of Transportation for the following described project:

LOR US 20 6.23 (1900 Feet West of SR 58) to 6.59 (SR 58) within the corporation limits of the City of Oberlin also known as ODOT PID 87698; and

WHEREAS, on the 3rd day of July, 2018, the City of Oberlin enacted Ordinance 18-54 AC CMS by which the City of Oberlin agreed to assume and bear one hundred percent (100%) of the entire cost of the improvement within the city limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration; and

WHEREAS, the City has deposited with the Ohio Department of Transportation, the City's estimated share of the cost of the project in the amount of Twenty Eight Thousand Sixty Four and 00/100 Dollars, (\$28,064.00); and

WHEREAS, ODOT's estimate of the City's share of the cost of the project has been revised from Twenty Eight Thousand Sixty Four and 00/100 Dollars, (\$28,064.00) to Twenty Nine Thousand Nine Hundred and Thirty Four and 00/100 Dollars, (\$29,934.00) based on the actual bid price for the work to be performed; and

WHEREAS, it is now necessary for the City to allocate an additional One Thousand Eight Hundred and Seventy and 00/100 Dollars, (\$1,870.00) for its local share of the cost of the project in order that the Director of Transportation may proceed with the aforesaid highway improvement.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, five-sevenths (5/7ths) of all members elected thereto concurring:

SECTION 1. That the additional sum of One Thousand Eight Hundred and Seventy and 00/100 Dollars, (\$1,870.00) is hereby appropriated for ODOT PID 87698 and the City of Oberlin Finance Director is hereby authorized and directed to pay the City's estimated cost of said improvement.

POSTED: 09/18/2018

SECTION 2. The City of Oberlin's ultimate share of its cost of ODOT PID 87698 shall be adjusted based on the actual cost of the improvements when those costs are known. The City of Oberlin shall pay its share of those costs over and above the amount to be paid from federal funds.

SECTION 3. The City of Oberlin hereby requests the Director of Transportation to proceed with the above described project.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio, to wit: to expedite the highway project and to promote highway safety and shall take effect immediately upon passage.
