### RESOLUTION No. R21-07 CMS

A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR PURSUANT TO OHIO REVISED CODE SECTION 5705.34 AS AN EMERGENCY MEASURE

WHEREAS, the Council of the City of Oberlin in accordance with the provisions of the law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2022; and

WHEREAS, the Budget Commission of Lorain County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill tax limitation:

NOW, THEREFORE, be it Resolved by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION 1. By the Council of the City of Oberlin, Lorain County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

SECTION 2. That there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as set forth in the **Attached Schedule A and B**.

SECTION 3. That the Clerk of Council is hereby directed to deliver a certified copy of this Resolution to the Lorain County Auditor, as soon as possible, after approval by Oberlin City Council.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio or to provide for the usual daily operation of a municipal department, to wit: **to ensure the property tax rates are approved and submitted to the County Budget Commission and County Auditor as soon as possible,**


**prior to the November 2, 2021 filing deadline** and provided that it is elevated to emergency status by the affirmative vote of at least five members of Council and receives the affirmative vote of at least five members of Council upon final passage, it shall go into full force and effect from and immediately after its passage; otherwise, it shall take effect at the earliest date allowed by law.
