## **ORDINANCE No. 22-17 AC CMS**

**AN ORDINANCE AUTHORIZING THE CITY MANAGER TO APPLY FOR CAPITAL GRANT FUNDS FROM THE STATE OF OHIO AND AUTHORIZING A LOCAL MATCH AS AN EMERGENCY MEASURE**

WHEREAS, the City of Oberlin desires to install an outdoor community Splash Pad at Park Street Park to be utilized by the public; and

WHEREAS, the City of Oberlin has the authority to apply for, accept and administer grant funds received through the State of Ohio; and

WHEREAS, the City of Oberlin desires to apply to the Ohio General Assembly for State of Ohio Capital Grant Funds for said Splash Pad.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION 1. That the City Manager is hereby authorized to apply for a State Capital Grant Fund in the amount of \$150,000.00 for the Oberlin Community Splash Pad Project.

SECTION 2. That if approved for the Grant, the City Manager is hereby authorized to provide a local match of \$50,000.00 for the Oberlin Community Splash Pad Project.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio or to provide for the usual daily operation of a municipal department, to wit: to provide for the timely application for grant funding so as to facilitate the installation of a community Splash Pad for the use and enjoyment of the citizens of the City of Oberlin and provided that it is elevated to emergency status by the affirmative vote of at least five (5) members of council and receives the affirmative vote of at least five (5) members of council upon final passage, it shall go into full force and effect from and immediately after its passage; otherwise, it shall take effect on the earliest date allowed by law.
