ORDINANCE No. 22-54 AC CMS

AN ORDINANCE AUTHORIZING AN INCREASE IN COMPENSATION FOR THE CLERK OF COUNCIL AND AMENDING ORDINANCE 07-51 AC CMS, AS AMENDED, APPOINTING THE CITY CLERK/CLERK OF OBERLIN CITY COUNCIL AS AN EMERGENCY MEASURE

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION 1. That the salary of the Clerk of Council is hereby increased to \$75,740 annually, effective May 28, 2022, plus those benefits provided in Ordinance No. 07-51 AC CMS, as amended.

SECTION 2. That subsection 2. of Section 1 of Ordinance 07-51 AC CMS, as amended, passed May 21, 2007, is hereby amended to read as follows:

2. All City of Oberlin full-time employee benefits, including, but not limited to, OPERS retirement contributions, medical insurance coverage, and vacation and sick leave; and \$150,000 of life insurance; OPERS (The Employer share and an additional salary OPERS allowance shall be paid to the employee which shall be in the amount of the employee share less 3% until May 28, 2027 and thereafter the additional salary OPERS allowance shall be equivalent to the employee share.)

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio or to provide for the usual daily operation of a municipal department, to wit: to implement a merit increase for the Clerk of Council to coincide with her anniversary date at the earliest date possible and provided that it is elevated to emergency status by the affirmative vote of at least five members of Council and receives the affirmative vote of at least five members of Council upon final passage, it shall go into full force and effect from and immediately after its passage; otherwise, it shall take effect at the earliest period allowed by law.
