Temporary Dumpster Service Rules

The number of temporary dumpsters is limited. Residents requiring temporary dumpster service are urged to apply early. Temporary dumpster service is suspended two weeks during the month of May each year.

Temporary dumpster service is provided only where the location is such that the City can deliver, service, and remove the dumpster. Trees, low wires, etc., may make it impossible to provide service at a particular location. Dumpsters must be placed on a paved or graveled surface, the City will not place dumpsters in grass area.

The person requesting the dumpster assumes all liability for damages resulting from the placement or servicing of the dumpster, including, but not limited to damage to yards, driveways, shrubbery, sidewalks, and buildings. **Loaded trucks may exceed 58,000 lbs. Damage to incompletely cured, substandard, weakened, or sandstone sidewalks is likely.**

Temporary dumpsters are available in 6-yard capacity and 10-yard capacity for a maximum of 3 weeks. Persons ordering a temporary dumpster are required to pay in advance for the dumpster at the Public Works Department located at 85 S. Main Street.

- **Basic Service:** Delivery of a dumpster for a one week period and one collection.
- **Additional Collection:** Collections beyond the one provided with basic service. Please call 775-7218 to schedule additional collections.
- **Additional Time:** Additional weeks (up to 2 available) after one provided in basic service. Note: Demurrage fee applied to additional weeks. Additional weeks must be scheduled and paid for at the initial submittal of the application.
- **Demurrage Fee** \$30.00 charge for each additional week.

Dumpsters are delivered on FRIDAY mornings. The City will make a single attempt to deliver the dumpster. If the dumpster cannot be set due to actions of the customer (e.g., cars in the way) a \$20.00 fee will be charged and the balance of the prepayment would be refunded to the customer. **There will be no other refunds or credits.**

Dumpsters are picked up on FRIDAY mornings. At the end of the scheduled period, the dumpster will be removed without further notice.

Prohibited Materials: The following materials shall not be placed in ANY dumpster: hazardous or infectious wastes, tires, storage batteries, appliances still containing refrigerants or in which the refrigerant was not removed by a licensed technician, brush, grass clippings or other yard waste (other than a nominal amount incidental to other refuse), waste oil, bricks, rocks or concrete, dirt, paint, paint thinner, varnish, herbicides, pesticides, lawn fertilizer, hydraulic fluid, gasoline, kerosene, or any material prohibited by State or Federal law from being landfilled.

6-yard dumpsters: This size dumpster is provided for excessive amounts of household trash and debris. Large amounts of construction debris is not permitted. Shingles in quantity greater than 2 bundles are not permitted. Sheet goods such as plywood in the dumpster it must be cut into 2' x 4' or smaller pieces. Boards and structural lumber (2"x4" and smaller) must be cut to 4' lengths or less. Loose items such as insulation or sawdust must be bagged. If the dumpster contains items not deemed acceptable it will be the responsibility of the customer to remove the excess before service.

10-yard dumpsters: This size dumpster is provided for small scale home renovation/improvement projects as well as home, basement and small garage clean-out. Items permitted include: bricks, cabinets, carpet, concrete, drywall, fixtures, insulation, lath & plaster, metal, shingles, siding, tile, lumber, boxes of household junk, filing cabinets, furniture and white goods (stoves, refrigerators (freon must be removed and appliance tagged by a certified technician), washers, dryers).

Dumpsters will not be serviced until materials are properly loaded. Do not overload dumpsters. Dumpsters are full when the material reaches the top sill. If the amount of materials in the dumpster exceed intended capacity, the city will bill the customer \$18.00 per cubic yard.
