ORDINANCE No. 23-29 AC CMS

AN ORDINANCE TO APPROVE AND ADOPT THE CURRENT REPLACEMENT PAGES TO THE CODIFIED ORDINANCES AS AN EMERGENCY MEASURE

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is presently before Council:

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio, a majority of all members elected thereto concurring:

- SECTION 1. That the recodification, editing, arrangement and numbering or renumbering of the ordinances and parts of ordinances as are set forth on **Exhibit A** attached hereto are hereby approved as parts of the various component codes of the Codified Ordinances of Oberlin, Ohio, within the 2023 Replacement pages, so as to conform to the classification and numbering system of the Codified Ordinances
- SECTION 2. That the sections and chapters set forth on $\underline{\textbf{Exhibit B}}$ are hereby added, amended or repealed so as to incorporate current state law provisions.
- SECTION 3. The complete text of the sections of the Codified Ordinances listed above are set forth in full in the current Replacement Pages to the Codified Ordinances which are hereby attached hereto as **Exhibit C**. Any summary publication of this ordinance shall include a complete listing of these sections. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.
- SECTION 4. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 5. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio or to provide for the usual daily operation of a municipal department, to wit: to conform local police power regulations to state law to ensure the efficient operation of the Police Department and provided that it is elevated to emergency status by the affirmative vote of at least five members of Council upon final passage, it shall go into full force and effect from and immediately after its passage; otherwise, it shall take effect on the earliest date allowed by law.
