# ORDINANCE 23-43 AC CMS

AN ORDINANCE ACCEPTING THE DEDICATION OF REAL PROPERTY FROM THE OBERLIN COLLEGE BOARD OF TRUSTEES AND FROM THE BOARD OF EDUCATION OF THE OBERLIN CITY SCHOOL DISTRICT AS PART OF THE NORTH PARK STREET RIGHT OF WAY AS AN EMERGENCY MEASURE

WHEREAS, to ensure the safety of the traveling public, the City of Oberlin has determined to increase the width of the public right-of-way on North Park St., from forty feet to sixty feet, north of East Lorain St.; and

WHEREAS, on April 25, 2023, the Oberlin Planning Commission approved the North Park Street Right-of-Way Dedication Plat; and

WHEREAS, Oberlin College Board of Trustees and the Board of Education of the Oberlin City School District have agreed to donate additional property and have executed the North Park Street Right-of-Way Dedication Plat.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

- SECTION 1. That the dedication of real property from Oberlin College Board of Trustees and the Board of Education of the Oberlin City School District is hereby accepted.
- SECTION 2. That the City Manager is hereby authorized and directed to execute the North Park Street Right-of-Way Dedication Plat in the form attached hereto.
- SECTION 3. That the Law Director is hereby authorized and directed to file the North Park Street Right-of-Way Dedication Plat with the Lorain County Recorder's Office.
- SECTION 4. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 5. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Oberlin, Ohio or to provide for the usual daily operation of a municipal department, to wit: to ensure the safety of the traveling public and provided that it is elevated to emergency status by the affirmative vote of at least five members of Council and receives the affirmative vote of at least five members of Council upon final passage, it shall go into full force and effect from and immediately after its passage; otherwise, it shall take effect at the earliest period allowed by law.




