

# CITY OF OBERLIN, OHIO

## ORDINANCE No. 23- 81 AC CMS

AN ORDINANCE AMENDING SECTIONS 111.02 (a) AND (b) OF THE CODIFIED ORDINANCES OF THE CITY OF OBERLIN RELATIVE TO THE SALARY OF THE PRESIDENT, VICE-PRESIDENT, AND MEMBERS OF OBERLIN CITY COUNCIL

THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION 1. That Sections 111.04 (a) and (b) of the Codified Ordinances of the City of Oberlin, presently reading as follows:

“111.02 GENERAL PAY PROVISIONS.

- (a) Effective January 1, 2016 the salary of the President of Council shall be fourteen thousand dollars (\$14,000) per year, and the salary of the Vice President of Council shall be twelve thousand nine hundred twenty-five dollars (\$12,925) per year.
- (b) Effective January 1, 2016 the salary of all of the other members of Council shall be twelve thousand dollars (\$12,000) per year.”

be and hereby are, amended to read as follows:

“111.02 GENERAL PAY PROVISIONS.

- (a) Effective January 1, 2026 the salary of the President of Council shall be eighteen thousand six hundred thirty dollars (\$18,630) per year, and the salary of the Vice President of Council shall be seventeen thousand two hundred dollars (\$17,200) per year.
- (b) Effective January 1, 2026 the salary of all of the other members of Council shall be fifteen thousand nine hundred sixty eight dollars (\$15,968) per year.”

SECTION 2. That pursuant to Section III, Paragraph E, of the Charter of the City of Oberlin, said change in salary shall be effective from and after the first Monday in January 2026.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance shall take effect on the earliest date allowed by law.
