

INVITATION TO BID

Sealed bids for <u>Contract 2024-01 for Park Street Park Splashpad</u> will be received at the Oberlin Recreation Department 36 South Prospect Street, Oberlin, Ohio 44074, until **4:30 p.m. on Friday, April 5, 2024,** at which time and place said bids will be publicly opened and read aloud.

Specifications, plans and bidding documents may be obtained from the **SE Blueprint**, www.seblueprint.com, click on Plan Room. Bids must be submitted on original documents.

All bids shall be signed and submitted on the forms bound in the contract documents. Bids shall be submitted in a sealed envelope marked "SPLASH PAD PROJECT" Each bid must be accompanied by a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code which shall be either a certified check payable to the City of Oberlin, or a bid bond satisfactory to the City, in the sum of ten percent (10%) of the price bid. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

There will be a non-mandatory pre-bid meeting in the Conference Room at Oberlin Old City Hall located at 69 South Main Street, Oberlin, Ohio 44074, <u>at 10:00 a.m., Thursday, March 21, 2024.</u>

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be substantially completed no later than October 4, 2024. The final completion date is October 31, 2024. All contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project.
