AN ORDINANCE TO AMEND CHAPTER 305 OF THE CODIFIED ORDINANCE OF THE CITY OF OBERLIN REGULATING THE PARKING OF MOTOR VEHICLES IN RESIDENTIAL DISTRICTS

WHEREAS, Ordinance No. 23-35 AC CMS amended certain provisions of Chapter 305 of the City of Oberlin, Codified Ordinances, regarding parking in residential districts and established penalties.

WHEREAS, Council desires to amend Chapter 305 of the Codified Ordinances of the City of Oberlin to incorporate existing penalties for parking infractions.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION I. That Chapter 305 of the Codified Ordinances of the City of Oberlin be and is hereby amended to read as set forth in Exhibit A attached.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance shall take effect on the earliest date allowed by law.

305.01 Parking regulations by executive order.

305.022 Designation of parking regulations.

305.99 Penalty.

305.01 PARKING REGULATIONS BY EXECUTIVE ORDER

The locations of and limitations on the duration of parking on public streets in residential districts may be made by executive order of the City Manager, Council shall be promptly advised on all such orders. Copies of the executive order shall be made available to the public in a form and manner prescribed by the City Manager.

305.02 DESIGNATION OF PARKING REGULATIONS

For the purpose of the designation of no parking or other limitations the executive order issued by the City Manager shall provide for appropriate signage.

305.99 PENALTY

Any person who violates the provisions of an Executive Order issued in accordance with this Chapter shall be subject to the same penalties as are set forth in Section 351.99(4) of these Codified Ordinances.
