ORDINANCE No. 23-35 AC CMS

AN ORDINANCE TO AUTHORIZE THE CITY MANAGER TO ESTABLISH REGULATIONS FOR PARKING IN THE RESIDENTIAL DISTRICTS AND AMENDING CHAPTER 305 OF THE CODIFIED ORDINANCES OF THE CITY OF OBERLIN AS AN EMERGENCY MEASURE

WHEREAS, this Council deems it necessary to facilitate flexibility in the regulation of parking on public streets in residential districts within the City to ensure an adequate number of on-street and off-street parking spaces based upon sound planning principles with consideration of the social, environmental, and economic costs of providing said parking, to ensure orderly vehicular movement, to ensure efficient access for emergency and delivery vehicles.

THEREFORE, BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION I. That Chapter 305 of the Codified Ordinances of the City of Oberlin be and is hereby amended as is set forth on Exhibit A attached hereto

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the citizens of the City of Oberlin, Ohio, or to provide for the usual daily operation of a municipal department, to wit: to ensure orderly vehicular movement and efficient access for emergency and delivery vehicles in the residential districts without delay, and provided that it is elevated to emergency status by the affirmative vote of at least five members of Council and receives the affirmative vote of at least five members of Council upon final passage, it shall go into full force and effect from and immediately after its passage; otherwise, it shall take effect on the earliest date allowed by law.

305.03 PARKING REGULATIONS BY EXECUTIVE ORDER.

The locations of and limitations on the duration of parking on public streets shall be made by executive order of the City Manager, Council shall be promptly advised on all such orders. Copies of the executive order shall be made available to the public in a form and manner prescribed by the City Manager.

305.04 DESIGNATION OF NO PARKING AREAS; CURB PAINTING

For the purpose of the designation of no parking or other limitations on parking, the executive order issued by the City Manager shall provide for appropriate signage.

305.99 PENALTY.

An administrative penalty of fifty dollars (\$50.00) for a first infraction and one hundred dollars (\$100.00) for each subsequent infraction shall be assessed against any person who violates the provision of an executive order made pursuant to Section 305.01. Said penalty shall be paid to the Oberlin Police Department. Any person who fails to pay an administrative penalty shall be guilty of a minor misdemeanor.
