AN ORDINANCE ENACTING NEW SECTION 305.05 OF THE OBERLIN CODIFIED ORDINANCES AUTHORIZING THE DESIGNATION OF TEMPORARY NO PARKING TOW AWAY ZONES TO GO INTO IMMEDIATE EFFECT

BE IT ORDAINED by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION I. That new section 305.05 of the Codified Ordinances of the City of Oberlin be and is hereby enacted as is set forth on **Exhibit A** attached hereto

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. To provide for orderly vehicular movement and to promote public safety during special events and emergencies and provided that at least five (5) members of the Council determine by motion that this Ordinance shall go into full force and effect immediately after its passage; otherwise, it shall take effect on the earliest date allowed by law.

EXHIBIT A

CHAPTER 305.05

- (a) The City Manager is hereby authorized to designate by order, any street, or any part of any street, within the Municipality as a "Temporary-No Parking-Tow Away Zone," as deemed necessary or as recommended by the Chief of Police during celebrations, parades, other special events or in the event of an emergency. Such order shall not remain in effect for a period in excess of 72 hours.
- (b) Whenever the City Manager designates a street or part of a street as a "Temporary No Parking—Tow Away Zone" for a pre-planned event, the City Manager shall cause signs to be posted in conspicuous places at least 12 hours in advance or such other time(s) as deemed appropriate based on the basis for the designation and location of the posting. Advance posting is not required in the case of an emergency. Such signs may be posted on permanent or temporary structures as deemed appropriate by the City Manager.
- (c) Whenever a street or part of a street has been designated as a "Temporary—No Parking—Tow Away Zone," the City Manager may authorize vehicles to stop for the loading and unloading of passengers or materials attendant to the event unless the street has been closed.
- (d) The City Manager, Chief of Police, or other police officer may order any vehicle in violation of this section to be towed, and the owner of such vehicle shall be responsible for the payment of all costs of towing plus applicable storage charges.
- (e) The owner or operator of any motor vehicle in violation of the provisions of this Section shall be deemed guilty of a minor misdemeanor.
