# COMMERCIAL DUMPSTER RULES

Dumpsters are provided only to areas where the location is such that the City can deliver, service, and remove the dumpster. The person requesting the dumpster assumes all liability for damages resulting from the placement or servicing of the dumpster, including, but not limited to damage to yards, driveways, shrubbery, sidewalks, overhead wires and buildings.

If dumpsters are inaccessible when the City comes to service or to remove the dumpsters, an additional service fee may be assessed. If additional servicing is desired, such service will be on an on-call basis. Commercial customers need to call at least two work days prior to the time dumpster is to be serviced.

Due to federal, state, and local laws, certain items cannot be collected, including castings, large car parts, motor oil, waste oils, tires, batteries, hazardous or infectious wastes, yard waste, brush, and wet paint. Appliances containing refrigerants (refrigerators, freezers, air conditioners, de-humidifiers) cannot be accepted unless the refrigerant has been removed from the appliance. This must be performed by a certified technician who will place a removal certification on the appliance. ***The city will not collect these appliances unless the required certification is in place.***

White goods (stoves, refrigerators, washers, dryers) are not to be placed in the dumpsters. These items are to be placed in front of the dumpster. When you call to have the dumpster serviced, let the City know there are white goods to be collected.

## DUMPSTER FEES AND SERVICES

Customers whose service is less than one cubic yard and where a dumpster is not required will be charged \$18.98 per month. Dumpsters are full when the refuse is level with the top. Dumpsters which have refuse piled on top or where refuse is beside the dumpster will have additional charges assessed.
