RESOLUTION No. R25-06 CMS

A RESOLUTION REQUESTING THAT THE COUNTY AUDITOR, PURSUANT TO OHIO REVISED CODE SECTION 5705.03, CERTIFY TO THE CITY OF OBERLIN THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY THE RENEWAL OF CERTAIN LEVIES, TO GO INTO IMMEDIATE EFFECT

WHEREAS, two levies, one for Current Expenses and one for Collection and Disposal of Garbage and Refuse, pursuant to Ohio Revised Code Sections 5705.19, 5705.25 and 5705.192, were approved by the voters of the municipality on May 4, 2021, and expire December 31, 2025, with the last collection year being calendar year 2026; and

WHEREAS, in order to continue to pay for current expenses of the municipality and the collection and disposal of garbage and refuse, it is necessary that a renewal of those levies be placed on the November 4, 2025, ballot.

NOW, THEREFORE, be it Resolved by the Council of the City of Oberlin, County of Lorain, State of Ohio:

SECTION 1. That pursuant to Ohio Revised Code Section 5705.03, the City of Oberlin hereby requests that the Lorain County Auditor certify to the City of Oberlin the total current tax valuation of the City and the dollar amount of revenue that would be generated by a renewal of the existing 1.2 mill levy for Current Expenses of the municipality that expires on December 31, 2025, and a renewal of the existing 3.0 mill levy for the Collection and Disposal of Garbage and Refuse that expires on December 31, 2025, as authorized by Sections 5705.19(A), 5705.19(V) and 5705.25 of the Ohio Revised Code;

SECTION 2: The taxes are to be for a term of five (5) years, shall be levied upon the entire territory of the City of Oberlin located within Lorain County, and shall be for a renewal levy to be placed upon the tax list and duplicate for the tax year beginning in 2026, first due in calendar year 2027. The levies shall be placed on the November 4, 2025 ballot to be submitted to the entire territory of the City of Oberlin.

SECTION 3. That the Clerk of Council is hereby directed to immediately certify a copy of this Resolution to the Auditor of Lorain County upon its passage.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning or relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 5. To ensure that the County Auditor certifies the total current tax valuation of the City and the dollar amount of revenue that would be generated in order to pass legislation for the renewal of certain City of Oberlin tax levies prior to the deadline for placing levies on the November 2025 ballot, and provided that at least five (5) members of Council determine by motion, this Resolution shall go into full force and effect immediately after its passage; otherwise, it shall take effect on the earliest date allowed by law.
