In addition, the Applicant will be responsible for all persons in the group or organization using the facility; assume responsibility for any damage to the facility; park only in designated areas; observe all posted rules; and not allow the consumption of alcoholic beverages. Certain areas of City Parks are "Tobacco Free Zones" and the use of tobacco products is prohibited. Please observe Park signage in those areas.
